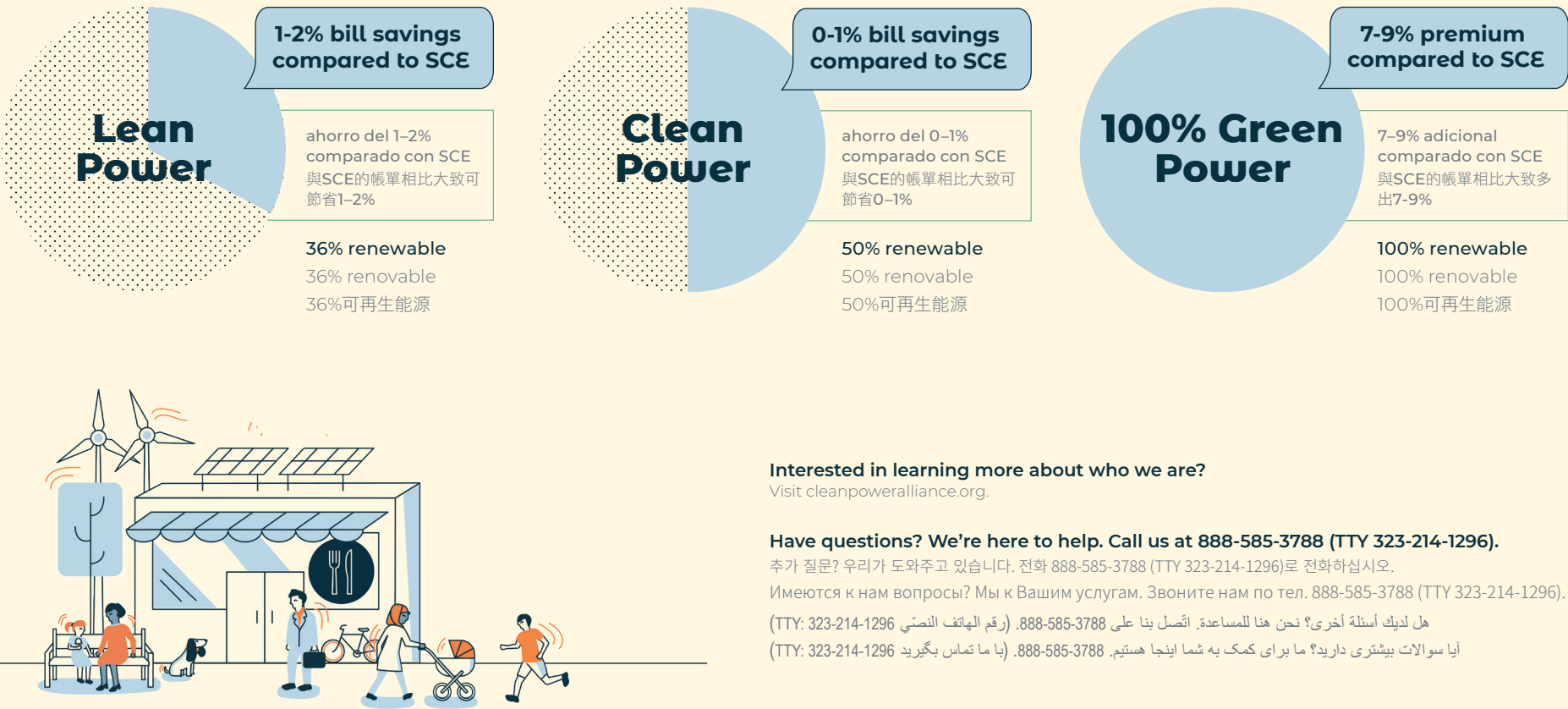

Terms and Conditions of Service

Clean Power Alliance electric generation rates are competitive. Available rates can be reviewed at cleanpoweralliance.org or by contacting Clean Power Alliance at 888-585-3788 (TTY 323-214-1296). Any changes to Clean Power Alliance rates will be adopted at duly noticed public meetings of the Clean Power Alliance Board of Directors.

Southern California Edison (SCE) collects from Clean Power Alliance customers authorized charges for delivering power to your home or business and for providing other services. These components of your electric bill are the same whether you buy electricity from Clean Power Alliance or SCE.

Southern California Edison also charges Clean Power Alliance customers a Power Charge Indifference Adjustment (PCIA) and a Franchise Fee Surcharge. Both are calculated based on the number of kilowatt hours used each month. The PCIA is intended to ensure that customers who switch to Clean Power Alliance pay for energy that was acquired by SCE to serve them prior to their switch. Note that Clean Power Alliance rates are competitive with SCE's rates, even with these fees.

Billing: Each month, Clean Power Alliance customers receive a single monthly bill from SCE, just as they would under SCE bundled service. This bill includes all electric charges, including Clean Power Alliance's power generation charges. SCE will continue to charge you for transmission and distribution services they provide; this includes the cost of transmitting electricity to your home or business.

Enrollment: You were automatically enrolled in Clean Power Alliance, unless you opted out, on your scheduled meter read date on or following February 1, 2019.

Discount Programs: If you are currently enrolled in the California Alternative Rates for Energy (CARE) program, the Family Electric Rate Assistance (FERA) program, Medical Baseline, Level Pay or Summer Discount Program, you will continue to receive all benefits and discounts as a Clean Power Alliance customer.

Opt out: You have the right to opt out without penalty at any time. You will not be charged any fees by Clean Power Alliance if you opt out or if you cancel electric service altogether (for example, if you move). However, customers who opt out of Clean Power Alliance after service launch may be charged a one-time account processing fee by SCE (currently 50 cents*), and will be

prevented by SCE from returning to Clean Power Alliance for a minimum of twelve months. By opting out, you will also be subject to SCE's then current rates and terms and conditions of service. For details on SCE's rates and terms and conditions, please visit sce.com/tnc. If you opt out, you will still be charged for all electricity you used before the transfer of electric service. Accounts will be transferred when the electric meter is read and cannot be transferred during the middle of a billing cycle. In order for your request to be processed on your next meter read date, your request must be received at least 5 business days prior to the date on which the meter is read. To opt out, please call Clean Power Alliance at 888-585-3788 (TTY 323-214-1296) or visit cleanpoweralliance.org. Please have your electric bill handy so you have the information needed to process the request.

Failure to pay: Clean Power Alliance may transfer your account to SCE upon 14 calendar days' written notice to you if you fail to pay any portion of the Clean Power Alliance charges on your bill. If your service is transferred, you may be subject to additional requirements by SCE.

How does it work?

Your city or county chose to offer you new clean energy options through **Clean Power Alliance**. Businesses and other non-residential customers in your area will automatically receive energy purchased by Clean Power Alliance that has higher renewable content and is competitively-priced with Southern California Edison (SCE). Starting on your first electricity meter read date in **May 2019**, you'll be automatically enrolled at the default level chosen by your city or county, **100% Green Power**, which provides 100% renewable content but you can choose a different rate at any time. SCE will continue to deliver power, send utility bills, be responsible for resolving any electricity service issues, and offer incentives to qualified customers.

¿Cómo funciona?

Su ciudad o condado escogieron ofrecerle nuevas opciones de energía limpia por medio de **Clean Power Alliance**. Las empresas y otros clientes no residenciales en su área recibirán automáticamente energía comprada por Clean Power Alliance que tiene un contenido renovable más alto y precios competitivos con Southern California Edison (SCE). A partir de la primera fecha de lectura de su medidor eléctrico en **mayo de 2019**, será inscrito automáticamente en el nivel predeterminado escogido por su ciudad o condado, **100% Green Power (Energía 100% Verde)** que ofrece un contenido renovable de 100%, pero usted puede escoger una tarifa diferente en cualquier momento. SCE seguirá transmitiendo energía, enviando facturas, resolviendo cualquier problema del servicio eléctrico y ofreciendo incentivos a los clientes cualificados.

它如何運作？

您的城市或縣選擇由清潔電力聯盟向您提供清潔能源新方案。您所在地區的企業用戶和其他非住宅用戶將會自動獲得由清潔電力聯盟購買的能源，這些能源具有更高的可再生含量，價格比起南加州愛迪生公司（SCE）亦有十足的競爭力。您從**2019年5月**第一次電錶讀取日當天開始，就會自動被登記參加貴市或貴縣所選的預設電力方案—**100% Green Power（綠色電力）**，此項方案可再生含量佔100%，而且您可以隨時改選其他方案。SCE會繼續輸送電力，寄發電費其帳單，負責解決所有電力服務問題，並對符合條件的用戶提供獎勵。

What will it cost?

100% Green Power will cost 7-9% more than SCE's default rate and currently costs about 5% less than SCE's 100% renewable rate. The few extra dollars a month is an easy way to show your organization's environmental leadership while building a stronger economy. Compare your Clean Power Alliance and SCE rate options by using our bill comparison tool at cleanpoweralliance.org/compare to decide which option is best for your organization's priorities. Clean Power Alliance supports customer choice, so you can choose a different rate option or decide to return to SCE as your energy provider.

What are my choices?

If you do nothing, you will continue at your community's default rate. Want a different rate? No problem. You can change your rate at any time by selecting one of Clean Power Alliance's other two rate options: **Lean Power** or **Clean Power**. You can also decide to return to SCE by visiting cleanpoweralliance.org or calling us at **888-585-3788**. No matter the rate option, Clean Power Alliance offers businesses the shared benefits of local management and control, stable, competitive rates, and higher renewable content.

¿Cuánto costará?

100% Green Power costará 7–9% más que la tarifa predeterminada de SCE y actualmente cuesta alrededor de 5% menos que la tarifa 100% renovable de SCE. Los pocos dólares adicionales al mes son una manera fácil de mostrar el liderazgo ambiental de su organización y a la vez construir una economía más fuerte. Compare sus opciones de tarifas de Clean Power Alliance y de SCE usando nuestra herramienta de comparación de tarifas en cleanpoweralliance.org/compare para decidir qué opción es la mejor para las prioridades y la economía de su organización. Clean Power Alliance respalda la capacidad de elegir de los clientes, por lo tanto, usted puede escoger una opción de tarifa diferente o decidir regresar a SCE como su proveedor de energía.

¿Cuáles son mis opciones?

Si no hace nada, continuará con la tarifa predeterminada de su comunidad. ¿Quiere una tarifa diferente? No hay problema. Puede cambiar su tarifa en cualquier momento al seleccionar una de las otras dos opciones de tarifas de Clean Power Alliance: **Lean Power (Energía Lean, 36% renovable)** o **Clean Power (Energía Limpia, 50% renovable)**. También puede decidir regresar a SCE visitando cleanpoweralliance.org o llamándonos al **888-585-3788**. No importa cuál sea la opción de tarifas, Clean Power Alliance ofrece a las empresas los beneficios compartidos de la administración y el control local, tarifas estables y competitivas, y mayor contenido de energía renovable.

費用多少？

100% Green Power（綠色電力）比SCE的預設方案價格多出7—9%，目前的費用約比SCE100%可再生方案價格少5%。透過每個月多付區區數元這種簡單的方式，您的組織可以在共同建立一個強而有力的經濟之際證明自己在環保方面的領導地位。您可以利用我們在cleanpoweralliance.org/compare網頁提供的帳單比較工具，對您的清潔電力聯盟和SCE費率方案進行比較，來決定最能滿足您組織優先事項和成本需求的方案。清潔電力聯盟支持用戶的選擇，因此您可以改選其他方案或決定轉回SCE，由其擔任您的能源供應商。

我有哪些選擇？
