Introduction and Key Information

This document contains the applicable rates and credits for customers participating in the Clean Power Alliance Power Share and Community Solar programs. These rates and credits are continuously calibrated to ensure that Power Share and Community Solar program participants are receiving a 20% overall bill discount, on top of their existing rate. Customers enrolled in Power Share and Community Solar receive 100% renewable energy produced in communities defined as “disadvantaged” according to California Assembly Bill (AB) 327 within Clean Power Alliance or Southern California Edison (SCE) service territory.

Please see the official Power Share Tariff at cleanpoweralliance.org/powershare and the official Community Solar Tariff at cleanpoweralliance.org/communitysolar for full program eligibility requirements and program terms and conditions.

Clean Power Alliance's rates are established by its Board of Directors. Any changes to Clean Power Alliance rates will be adopted at duly noticed public meetings of the Board of Directors.

The rates shown in this document are for electric generation/supply only. Please visit SCE.com for delivery rates and schedules.

Rate Period Definitions

The name of your Clean Power Alliance rate schedule may not exactly match your SCE rate, as Clean Power Alliance offers simplified, consolidated rate options. This will not impact service, billing, or CARE, FERA, or Medical Baseline status. Seasons

For all rate schedules, seasons are defined as follows:

- **Summer:** season shall commence at 12:00 a.m. on June 1 and continue until 12:00 a.m. on October 1 of each year.
- **Winter:** season shall commence at 12:00 a.m. on October 1 of each year and continue until 12:00 a.m. on June 1 of the following year.

Holidays

Applicable holidays for rate time periods are as follows: New Year's Day (January 1), Presidents' Day (third Monday in February), Memorial Day (last Monday in May), Independence Day (July 4), Labor Day (first Monday in September), Veterans Day (November 11), Thanksgiving Day (fourth Thursday in November), and Christmas Day (December 25).

When any holiday listed above falls on Sunday, the following Monday will be recognized as a holiday. No change will be made for holidays falling on Saturday.

- **Mid-Peak:** 4:00 p.m. to 9:00 p.m. summer weekends/holidays and winter all days
- **Off-Peak:** 9:00 p.m. to 8:00 a.m. all year
- **Super Off-Peak:** 8:00 a.m. to 4:00 p.m. all year
