Clean Power Alliance is committed to giving every customer access to clean energy and choices when it comes to their energy needs. At any time, CPA customers can switch to our **100% Green Power** option, which provides 100% renewable energy, our **Clean Power** option, which provides 50% clean energy, or our **Lean Power** option, which provides 40% clean energy and usually offers a bill savings compared to SCE base rates. Reduced Rates for CARE, FERA, and Medical Baseline Customers in 100% Green Power Default Jurisdictions

Some Clean Power Alliance jurisdictions have selected **100% Green Power** as their default CPA rate product.¹ Customers in these jurisdictions that participate in California Alternate Rates for Energy (CARE), Family Electric Rate Assistance (FERA), or Medical Baseline receive **100% Green Power** at a reduced rate.

¹Jurisdictions on 2018 Vintage Residential Rates that have selected the 100% Green Power default are Agoura Hills, Alhambra, Beverly Hills, Calabasas, Camarillo, Claremont, Culver City, Hawthorne, unincorporated Los Angeles County (non CARE/FERA/Medical Baseline residential customers only), Malibu, Manhattan Beach, Ojai, Oxnard, Redondo Beach, Rolling Hills Estates, Santa Monica, Sierra Madre, South Pasadena, Thousand Oaks, unincorporated Ventura County, Ventura, and West Hollywood.

Rate Definitions

Seasons

For all rate schedules, seasons are defined as follows:

- **Summer:** season shall commence at 12:00 a.m. on June 1 and continue until 12:00 a.m. on October 1 of each year.
- **Winter:** season shall commence at 12:00 a.m. on October 1 of each year and continue until 12:00 a.m. on June 1 of the following year.

Holidays

Applicable holidays for rate time periods are as follows: New Year's Day (January 1), Presidents' Day (third Monday in February), Memorial Day (last Monday in May), Independence Day (July 4), Labor Day (first Monday in September), Veterans Day (November 11), Thanksgiving Day (fourth Thursday in November), and Christmas Day (December 25).

When any holiday listed above falls on Sunday, the following Monday will be recognized as a holiday. No change will be made for holidays falling on Saturday.

Rate Key

The name of your Clean Power Alliance rate schedule may not exactly match your SCE rate, as Clean Power Alliance offers simplified, consolidated rate options. This will not impact service, billing, or CARE, FERA, or Medical Baseline status.
